

APPLICANT'S CONSENT to personal data processing

hereinafter "the Subject", **agree** that the Federal Public Educational Institution of Higher Education "Nosov Magnitogorsk State Technical University", with its registered seat at 38, Lenin Ave., Magnitogorsk, 455000, Chelyabinsk region, hereinafter "the Data Processor", may process my personal data above under the Federal Act "On personal data" of July, 27 2006 No. 152-FZ, **for the purposes of** filing the applicant's personal data, arranging an enrollment competition, and, in case of admission, further forwarding of personal data to the University departments processing these personal data under the following conditions:

1 The Data Processor shall process my personal data with or without automation means, i.e. processing of personal data includes the following operations: collection, recording, systematization, accumulation, storage, clarification (updating, modification), use, transfer (distribution, provision, access), anonymisation, blocking, deletion, destruction as well as exchange (receipt, transfer) of personal data between the Data Processor and third parties in accordance with the legislation of the Russian Federation.

2 The Subject's Data shall be used solely for the purposes mentioned above.

3 A list of personal data to be processed under the Subject's consent can be found in the applicant's file.

4 The Subject shall give consent to inclusion of his/her personal data into public sources specified by the Decree of the Ministry of Education and Science of the Russian Federation "On the procedure of admission to educational institutions of higher professional education" No. 2895 dated December, 28 2011 (filed by the Ministry of Justice of the Russian Federation No. 23011 of January, 24 2012).

5 Subjects liable for military duty shall provide information on their parents in accordance with the Federal Act "On Military Duty and Military Service" No. 53-FZ dated March, 28 1998 and the Decree of the government "Regulation on military induction" U663 of November, 11 2006.

6 Subjects liable for medical examination shall provide personal data in accordance with the Decree "On the procedure of medical examination received by the minors, and specifically, when admitted to educational institutions and during the course of studies in them" No. 1346n of December, 21 2012.

7 With the written authority, the Data Subject shall have the right to claim for information regarding his/her personal data processing (in accordance with Paragraph 4, Article 14 of the Federal Act No. 152 of June, 27 2006).

8 Personal data of applicants who have not been enrolled in the Nosov Magnitogorsk State Technical University shall be depersonalised in due time specified by the personal data protection regulatory documents. The consent shall be valid at all times until the processing of the Subject's personal data is discontinued or until the Data Subject withdraws the Consent.
